In an independently-conducted evaluation and comparison of leading firms with an audited track record of at least ten years, Dash Investments was found to have outperformed 90% of the country's investment management firms over the last decade, while employing a highly conservative strategy. As was the case with almost all other financial advisory firms, the company suffered a down year in 2008 at the hands of the financial crisis. However, even in turbulent times, the firm has performed above the level of its peers and has maintained a client retention rate of nearly 100% since inception.

The company's primary focus is on value- and safety-based strategies. The firm's executive investment committee holds optimistic but tempered expectations for the future, with forecasted returns of 6% to 8% over the coming years.

In order to provide comprehensive and accurate information, our analysis of fees took into account not only the annual fees charged by other firms for their advisory services, but also the additional fees and hidden costs attached to the various financial products endorsed and sold by advisory firms, such as mutual funds and other investment strategies.

This study proved highly enlightening, offering insight into the sometimes-staggering layers of fees that retail portfolios are often unwittingly subjected to. While many firms appeared on the surface to offer a low fee basis for financial management services, a deeper look revealed that this was not always the case. The largest offenders were those employing fund management strategies, or, in other words, selling their clients into mutual funds and ETFs. Despite their reputation as cost effective tools for diversifying exposure, these products come with their own complex system of fees. In many cases, investors believed they were paying a reasonable 1% for investment management services when in actuality their gross fee basis was running as high as 2.5% - 3.5% per year.

Extending our analysis into the tax management side revealed still more to be concerned about. Not surprisingly, it was those same firms operating on a middleman model that jumped out at us most. Apart from accruing additional fees, these firms were found to be subjecting their clients' portfolios to the high turnover ratios common in mutual funds (80% on average), with attendant tax implications and transaction costs.

By keeping turnover to a very low 10%, Dash Investments' clients pay as much as 70% less in taxes as compared to the average advisor. By
